- h) the Bidder or any of its directors/shareholders is not listed on the Register of Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector;
- i) the Bidder or any of its directors/shareholders is not listed on the database of Restricted Suppliers;
- i) the Bidder has not:
 - i) abused the Employer's Supply Chain Management System; or
 - ii) failed to perform on any previous contract and has been given a written notice to this effect;
- k) The Bidder or any of its principals, directors or managers is <u>not</u> employed in the service of the State or any municipality. In the event that such principals are involved, official approval from the Executing Authority regarding carrying out remunerative work outside of the public service must be included in the tender submission; and
- I) The Bidder has completed the Compulsory Enterprise Questionnaire and there are no conflicts of interest which may impact on the tenderer's ability to perform the contract in the best interests of the employer or potentially compromise the tender process and persons in the employ of the state are permitted to submit tenders or participate in the contract.

Stage Two: Evaluation Criteria/Functionality

The evaluation on functionality criteria will be evaluated based on the following information:

- a) Attach verifiable experience of key staff who have previously worked on similar projects
- b) Attach relevant experience and skill of the main contractor and/or sub-contractor in working on similar projects
- c) Attach proof of locality of the main contractor and/or sub-contractor. (Fully functional operational office of the bidder).
- d) Each bidder must obtain a minimum of 70 points out of 100 points for functionality in order to qualify for evaluation in the next stage and preference using the 80/20 preference points systems.

Stage Three: Evaluation on Price and Preference

a) The Engineering Council of South Africa (ECSA) stipulates that where the location, size, character, form and function of the works has been defined through previous studies and investigations that have either formed part of the client's normal business practices or have been the subject of previous separate assignments by the same or another service provider, the remuneration can be determined using these guidelines based on the cost of the works. This provides a convenient way to express the fee payable if the cost of the works and the related extent of the services to be provided is reasonably clear.

ECSA further stipulates that the fees expressed as a percentage of the cost of the works will differ for different types of work due to different amounts of effort and engineering input required of the same cost of the works.

Fees will be negotiated based on Government Gazette no 39480, 04 December 2015, as per Clause 4.3.3.

- b) The Department will not evaluate bids on price as fees will be based on the gazette fees as published by the ECSA and shall be subject to negotiations before final allocation of the task is made to the consultants.
- c) The Department is committed to achieving the government's transformation objectives in terms of the Preferential Procurement Policy Framework Act. Therefore, Bids will be evaluated on 80/20 preference point system as prescribed in the Preferential Procurement Regulations 2017.
